FY 2024 Notice regarding the School Expense Subsidy (Shugaku Enjo)

Suginami City provides assistance with a part of necessary school expenses to the parents/guardians of children/students living in Suginami City and attending national or public elementary and junior high schools. Even if you received this subsidy during the last fiscal year, you need to reapply.

## Those eligible for the School Expense Subsidy

Parents/quardians living in Suginami City with children/students, for whom any of the following is applicable:

- (1) Those households receiving Public Assistance (education assistance under the Public Assistance Act)
- (2) Those households whose Public Assistance has been suspended or revoked after April 1st, 2023.
- (3) Those households whose total net income amount of all household members\* from January through December 2023 is less than the set amount.

(The City will approve based on the household members' inhabitant tax declaration contents, the income amounts, and the dependent status in FY<u>2024</u>.)





Special conditions" on the application form.



\*You can apply at any time. However, the subsidy will be paid from the month you applied. (Example: If you apply in May  $\rightarrow$  you will receive the subsidy for May and later.)

\* If there are any changes in the contents of your application, such as the status of your household, after submitting your application, please contact the School Affairs Section.

#### **Notification of approval of School Expense Subsidy**

The result of the application will be sent by postal mail to the parents/guardians after July.

The school your child is attending will be notified as well.

The application result will be kept strictly confidential and will not be used for any purpose other than services related to the School Expense Subsidy.

#### Confirming the income situation

If we are unable to confirm the total net income amount of all household members for January through December 2023, the approval review will be suspended.

#### **Payment of School Expense Subsidy**

If your application is approved, the subsidy will be paid into the bank account you provided on the application. Please designate the same account as the one for school lunch and other expenses.

you will be requested to submit the documents to prove your income.

In case of special circumstances such as a long-term delinquency of school fees or when it is deemed necessary by the school principal or the Board of Education, the subsidy will be paid into the bank account of the principal of the school your child is attending.

## Items of expenditure for which subsidy may be provided

①Cost of School supplies ②School event costs ③Costs for PE (physical education) goods (junior high school students only / goods for judo and kendo) ④Fee for school life guidance form ⑤Cost of school supplies when starting school @Field trip costs @School trip costs @Yearbook cost @Medical expense (only if those receiving Public Assistance have medical treatment for the illnesses registered as "school illnesses") @School lunch fees

- \*To those receiving Public Assistance, the social welfare office will pay 1 to 5 and 10.
- \*Regarding 5the cost of school supplies when starting school
- · This subsidy will be paid to first-grade elementary school and junior high school students who are approved to receive School Expense Subsidy in April. If you have received this subsidy before entering school, the subsidy will not be repaid.
- The cost of school supplies when starting junior high school will be paid to the 6th grade elementary school students in March. Eligible parents/guardians will be notified by postal mail after December.

#### The Subsidy for Students attending Special Class (Shugaku Shorei)

There is a system to assist a part of school expenses to parents of children/students attending special classes or children/students with disabilities that qualify for special class/school even if they attend regular class. If you wish to apply, please inquire to the School Affairs Section.

#### **Multilingual information**
