

# Notice of Support Benefit for Rising Prices of Goods (70,000 Yen)

- The Support Benefit for Rising Prices of Goods (70,000 yen per household) is extended to households exempt from per capita resident tax, utilizing the government's Special Grant for Local Governments to Tackle Hikes.
- **Procedures are required in certain cases** to receive this benefit.

## Applicable Households

Households with residence registration in Suginami City as of December 1, 2023 (Base Eligibility Date), and with all members **exempt from per capita resident tax** for fiscal year 2023

## Amount of Benefit Payment

**70,000 yen**  
per household

## Eligibility and Procedures for the Benefit

### Eligible Households

**A** Among applicable households, those that **received the Support Benefit for Rising Prices of Goods (30,000 yen per household) in Suginami City** with no changes in their composition

**B** Among applicable households, those outside of category **A** (excluding those solely composed of dependents, etc. of individuals subject to resident tax for fiscal year 2023)

### No procedures required

A **Notice of Provision** will be sent to the heads of relevant households in stages, starting from January 22, 2024.

The benefit will be transferred to the account that received the previous Support Benefit for Rising Prices of Goods (30,000 yen per household).

Payments will be made in stages, starting from mid-February 2024.

### Procedures required

From January 22, 2024, **documents, including a Confirmation Form or an Application Form, will be sent** in stages to the heads of relevant households.

**Confirm the information on the back side before submission.**

Payment will be made about one month after the submission of your documents.

## Procedures (Only Applicable to Households under Category **B** on the Front Page)

### ▶ If **no members** of your household moved into Suginami City on or after January 2, 2023

- Documents, including the **Confirmation Form**, will be sent in stages, starting from January 22, 2024, to relevant households with members residing in Suginami City as of December 1, 2023 (Base Eligibility Date).
- Complete the confirmation form, attach the required documents (such as a photocopy of the passbook verifying the account to which the benefit will be transferred) as indicated in the enclosed notice, and **return them** to us.

### ▶ If **any member** of your household moved into Suginami City on or after January 2, 2023

- Documents, including the **Application Form**, will be sent in stages, starting from January 22, 2024, to households eligible as of December 1, 2023 (Base Eligibility Date).
- Complete the application form, attach the required documents (such as a Certificate of Tax Exemption for fiscal year 2023 issued by the municipality where each member who moved into Suginami City lived as of January 1, 2023), and **return them** to us.
- The application will not be accepted if anyone in your household is not exempt from paying the resident tax for fiscal year 2023.

### ▶ Electronic application forms are available for use

Both the confirmation and application forms can be submitted electronically through smartphones, computers, and similar platforms. Please access the URL or scan the 2D code provided in the enclosed notice to submit your application.

### ▶ Submission deadlines for confirmation and application forms

Postal application: **Friday, May 31, 2024 (must be postmarked by this date)**

Electronic application: **11:59 p.m. on Friday, May 31, 2024**
