# Notice of Support Benefit for Rising Prices of Goods (100,000 Yen) for Households Subject to Per Capita Resident Tax Only

- The Support Benefit for Rising Prices of Goods (100,000 Yen) for Households Subject to Per Capita Resident Tax Only for Fiscal Year 2023 is a special benefit extended to households subject to per capita resident tax only that utilizes the government's Temporary Special Grant for Local Governments to Tackle the Rising Price of Goods.
- Procedures are required in certain cases to receive this benefit.

### **Amount of Benefit Payment**

# 100,000 yen per household

### **Eligibility and Procedures for the Benefit**

### Eligible Households

• Households registered in Suginami City's Resident Registration System as of December 1, 2023 (Base Eligibility Date), in which all members are subject to per capita resident tax only for fiscal year 2023, or households that include both members who are subject to per capita resident tax only and members who are exempt from per capita resident tax for fiscal year 2023.

Eligible households for which the head of household has <u>a registered bank</u> <u>account for receiving governmental</u> <u>allowances\* and for which no</u> <u>members moved into Suginami City on</u> <u>or after January 2, 2023</u>

Bank account pre-designated through Mynaportal, etc. for receiving government benefits (Bank account registered as of January 26, 2024)

### No procedures required (in principle)

A **Notice of Provision will be sent** to the heads of relevant households in stages, starting from February 22, 2024.

In principle, benefits will be transferred to the bank account designated for receiving governmental allowances.

Payments will be made in stages, starting from late March 2024.

**Eligible households** 

outside of category (1)

### **Procedures required**

From February 22, 2024, documents, including a Confirmation Form or an Application Form, will be sent in stages to the heads of relevant households.

Confirm the information on the back side before submission.

Payment will be made about one month after the submission of your documents.

#### If no members of your household moved into Suginami City on or after January 2, 2023

- Documents, including the Confirmation Form, <u>will be sent in stages, starting from</u> <u>February 22, 2024</u>, to relevant households with members residing in Suginami City as of December 1, 2023 (Base Eligibility Date).
- Complete the confirmation form, attach the required documents (such as a photocopy of the passbook verifying the account to which the benefit will be transferred) as indicated in the enclosed notice, and **return them** to us.

### ▶ If any member of your household moved into Suginami City on or after January 2, 2023

- Documents, including the **Application Form**, <u>will be sent in stages, starting from February</u> <u>22, 2024</u>, to households eligible as of December 1, 2023 (Base Eligibility Date).
- Complete the application form, attach the required documents (such as a Certificate of Resident Tax Assessment for Fiscal Year 2023 (certifying subject to per-capita resident tax only) issued by the municipality where each member who moved into Suginami City lived as of January 1, 2023), and **return them** to us.

### Electronic application forms are available for use

Both the confirmation and application forms can be submitted electronically from a smartphone, computer, or other device. Please access the URL or scan the 2D code provided in the enclosed notice to submit your application.

## Submission deadlines for confirmation and application forms

Friday, May 31, 2024 (must be postmarked by this date)

### Information on Payment of Additional Child Benefits (50,000 Yen per Child)

- For households with children 18 years old or younger as of December 1, 2023 (Base Eligibility Date), who are eligible for the Support Benefit for Rising Prices of Goods (100,000 Yen) for Households Subject to Per Capita Resident Tax Only, <u>50,000 yen per child</u> will be provided separately.
- Information on additional benefit payments for children will be sent in stages starting from late March 2024 to <u>households who have received the Support Benefit for Rising Prices of Goods (100,000 Yen)</u> for Households Subject to Per Capita Resident Tax Only.
