Notice Regarding FY2024 Support Benefits for Rising Prices of Goods

Suginami City will provide benefits to households newly exempt from or taxed only on FY2024 inhabitant tax per capita. An additional payment will be provided to households that support children 18 years of age or younger. For details, please refer to the City's website (QR code to the right).

[Eligible households and value of support benefits]

- (1) Households registered as residents of Suginami City as of June 3, 2024, in which all members are exempt from or taxed only on FY2024 inhabitant tax per capita (prior to the fixed amount tax reduction) = 100,000 yen per household (limited to one payment per household) *Households that received FY2023 Support Benefits for Rising Prices of Goods (70,000 yen or 100,000 yen) are not eligible for payment.
- (2) Households eligible to receive (1) above that support children 18 years of age or younger (born on or after April 2, 2006) = 50,000 yen per child (paid to each household)

[Procedure]

- (1) We have sent notices to the heads of eligible households. Households that wish to receive benefits should send the necessary documents by post by October 31 (with a valid postmark for this date).
- (2) We will send notices to the heads of eligible households that received (1) in the order of processing starting in mid-August.

Applications for Suginami Municipal Elementary and Junior High Schools

Foreign nationals residing in Suginami City who wish to enroll their child in one of the city's municipal elementary schools for the April 2025 academic year will need to apply for enrollment. In addition, those who have a child who is currently attending a municipal elementary school and wish to enroll him or her in a municipal junior high school after his or her graduation in March 2025 will also need to apply.

To apply, please visit the School Affairs Section (East Wing, Suginami City Office 6F) during the month of September with documentation identifying the child's name, address, and date of birth (e.g., residence card).

For Guardians of Children Attending International Schools

Suginami City offers subsidies to reduce the burden of school fees and other related expenditures for guardians of children attending international schools.

[Eligibility] Applicants must fulfill all the following eligibility criteria:

- 1. The guardian has a child at the age for receiving compulsory education who is attending an international school accredited under the School Education Act
- 2. The child and guardian have an address registered in Suginami City and are living in the same household
- 3. The child, or the father or mother of the child, does not have Japanese nationality
- 4. The guardian is paying for the school fees
- 5. For guardians with a higher income, the amount remaining after the relevant deductions in Table 2 have been deducted from the guardian's income⁽¹⁾ in 2023 (January to December) is below the income cap listed in Table 1
- *For those who have employment or miscellaneous income (limited to income related to public pensions, etc.), income refers to the amount remaining after 100,000 yen (if the amount is less than 100,000 yen, then that amount) has been deducted from the total income.

This application is for the first half of the year. Each school has different periods for the first half of the year and application procedures, so please inquire for details. 


